### 1st Remark:-

As of 31 October 2013, share options in respect of 5,650,000 ordinary shares under the 2003 Scheme were outstanding but all of them remained unvested in accordance with the terms of grant as disclosed in the announcement of the Company dated 26 August 2010.

### 2<sup>nd</sup> Remark:-

On 28 June 2013, the Company granted share options in respect of a total of 14,600,000 ordinary shares to the Group Managing Director and eligible executives including directors of certain the Company's subsidiaries. Among the aforesaid share options granted, share options for 2,570,000 shares were conditionally granted to the Group Managing Director upon the approval of shareholders of the Company in general meeting as required under the Listing Rules and the terms of the ESOS 2013.

As of 31 October 2013, share options in respect of 14,600,000 ordinary shares under the ESOS 2013 were outstanding but all of them remained unvested in accordance with the terms of grant as disclosed in the announcement of the Company dated 28 June 2013.
