As of 31 August 2014, share options in respect of 4,650,000 ordinary shares under the 2003 Scheme were outstanding but all of them remained unvested in accordance with the terms of grant as disclosed in the announcement of the Company dated 26 August 2010.

#### 2<sup>nd</sup> Remark:-

On 28 June 2013, the Company granted share options in respect of a total of 14,600,000 ordinary shares to the Group Managing Director and eligible executives including directors of certain the Company's subsidiaries. Among the aforesaid share options, share options for 2,570,000 ordinary shares granted to the Group Managing Director were approved by the shareholders as required under the Listing Rules.

As of 31 August 2014, share options in respect of 13,400,000 ordinary shares under the ESOS 2013 were outstanding but all of them remained unvested in accordance with the terms of grant as disclosed in the announcement of the Company dated 28 June 2013.
